



## **Agreement for Academic and Scientific Co-operation and Exchange**

**between**

**Belarusian State Medical University,  
Minsk (Republic of Belarus)**

**and**

**Tehran University of Medical Sciences  
Tehran (Islamic Republic of Iran)**

### **Article 1**

Belarusian State Medical University (Minsk, Republic of Belarus) represented by **Professor Sergey P. Rubnikovich**, acting as Rector, and Tehran University of Medical Sciences (Tehran, Islamic Republic of Iran) represented by **Professor Abbas Ali Karimi**, acting as Chancellor, hereinafter referred to as Partners, have entered into this Agreement as follows:

### **Article 2**

Both Parties hereto are willing to co-operate in the following areas and shall undertake to:

- Exchange faculty staff, researchers, doctors and other research and administrative staff;
- Co-operate in the research projects;
- Organize lectures and symposia;
- Exchange academic, scientific, medical information and materials;
- Promote any other cooperation as may be mutually agreed.

### **Article 3**

This Agreement shall hold both Partners harmless from any financial obligations whatsoever. The Parties hereto agree to undertake all necessary efforts to raise money for the implementation of this Agreement.

### **Article 4**

All changes and supplements to this Agreement shall be consented by both Parties hereto in writing. The protocol of such changes and supplements shall be an integral part of this Agreement.

The Agreement may be terminated by either Partner as it sends notice in writing about such termination to the other Party.

### Article 5

The Partners shall undertake to settle any arising dispute by way of negotiation.

### Article 6

This Agreement shall come into force from the date of its signing by the representatives of both Universities and be valid for a period of five (5) years. This Agreement may be automatically renewed unless either University has informed the other of the termination hereof upon prior notice in writing six (6) months at the latest before the termination date.

This Agreement has been made in Feb. 2021 in English in two counterparts and signed by the representatives of both Universities.
