--Final Submission Requirement: Corresponding Authors of all accepted papers for EMBC'20 must upload the final version of the paper according to the author policies on or before the published final submission deadline. Even if no changes are recommended a final version of the paper MUST BE UPLOADED. The final version should reflect any revisions in response to reviewers' comments, if any, and fix ALL format issues. Manuscripts not following the format requirement of EMBC'20 will be excluded from the conference proceedings.

The final version of your manuscripts must be submitted by April 30, 2020 and it must comply with IEEE Xplore PDF standards, otherwise your paper may be removed from the final program. Please follow the instructions on the conference paper management system Submission site to properly convert your papers.

Corresponding authors are encouraged to complete a careful and thorough review, considering and applying review comments. Final Submissions cannot be changed or edited after the final submission deadline.

The paper management system only allows the corresponding author to complete the final submission of the paper. Co-Authors are not permitted to complete final submission of the paper.

--Important Guidelines for Finalization of your Manuscript and related data:

Make sure that your name and paper title are entered in 'Title Case' NOT in all 'UPPER CASE'. Please also enter the names of all authors in correct order when uploading the final version of your manuscript.

Each author should check their paper management system account profile to ensure the personal data is accurate, up to date, and absence of spelling or other errors; What is reflected in one's profile will be reflected in all subsequent platforms which share data with The conference paper management system.

It is the responsibility of the submitting Author to ensure that the document was viewable and without errors that would prevent the Conference from including the paper in the electronic proceedings.

It is a requirement of EMBS and PubMed that all published EMBC papers contain a statement indicating that approval to carry out experimental procedures involving human subjects or animals was obtained from the appropriate committee. Please review your paper and make sure that a statement in this regard is included in the final version of your paper. Papers which do not contain such statement related to experimental procedures in human subjects or animals are subject to publication rejection. Acceptance of a paper by the conference does not guarantee paper publication. For those investigators whose Institutions do not have formal ethics review committees, the principles outlined in the Helsinki Declaration of 1975, as revised in 2000, should be followed.

Example: "The experimental procedures involving human subjects described in this paper were approved by the Institutional Review Board". "The Institution's Ethical Review Board approved all experimental procedures involving human subjects". "The experimental procedures involving animal models described in this paper were approved by the Institutional Animal Care and Ethics Committee".

--Registration Fees:

In light of the COVID-19 crisis corresponding authors of accepted papers, will be allowed to submit the final version of their papers without the pre-requisite payment of registration fees, paper submission fees, and or over length page charges. This allows the conference to build its prospective program, without requiring the author to commit to the cost related to registration, in such an unsettling climate, and allows authors to navigate the changing landscape of institutional approval processes, and any travel restrictions. In all, the final submission of the accepted paper, communicates to the committee and the society your desire and commitment to remain a part of EMBC 2020.
