Thank you for submitting an abstract to be considered for presentation at the scientific sessions of the Joint Annual Meeting ISMRM-ESMRMB in Milan, Italy. I am pleased to inform you that your abstract, (title above), has been selected for presentation in an Oral scientific session. Each abstract will be allotted twelve minutes, of which nine minutes are for the presentation and three minutes are for discussion. As there will be ten papers presented during each oral session it is essential that you observe the time limits. Your presentation is tentatively scheduled during the following oral session:

Program numbers will be assigned in later this month. When you arrive at the meeting, however, please verify the time of your session in the official program in case there have been last-minute changes.

Keeping with changes that began in 2012: Oral Sessions, Traditional and Electronic Poster Presentations, and Study Group Meetings will all take place throughout the day, both during the morning after the plenary, immediately after lunch, and during the late afternoon.

Educational, Clinical, New Entrant, and E. K. Zavoisky Stipend Applicants should NOT register for the meeting until they have been notified of the status of their stipend application.

Please carefully read and follow the session guidelines and detailed presentation instructions which can be found at the ISMRM meeting website.

Computer projection will be used in all rooms. ALL presentations must be loaded onto our computer network servers in advance. An upload site will also be made available to you approximately one month before the meeting. Using this site for advanced uploading is recommended, however, we would still request that you check with the Speaker Ready Room to be sure your presentation is displaying properly. Presentation can be uploaded in the Speaker Ready Room no later than the day before the presentation.

Technical instructions and specifications are included with the session guidelines. In any case, plan to arrive early at the session room to allow yourself an opportunity to meet the moderators and to familiarize yourself with the audiovisual controls.

Identifying Products and Discussing Unlabeled Uses of Products: As these sessions will offer Continuing Medical Education credit, presenters are required to observe the following ISMRM policies regarding the content of CME presentations:

1. The content of CME activities does not promote the proprietary interests of any commercial entities.

2. Content must be restricted to pure science (dealing with physics, chemistry and biology, as opposed to the business lines or products of any commercial interest), industry issues and operation of devices, and should not include product or company names unless essential (and subject to restrictions on trade names below)
3. All recommendations involving clinical medicine must be based on evidence that is accepted within the profession of medicine as adequate justification for their indications and contraindications in the care of patients.
4. All scientific research referred to, reported or used in support or justification of a patient care recommendation must conform to generally accepted standards of experimental design, data collection and analysis.
5. Generic and Trade Names: Presentations must give a balanced view of therapeutic options. Speaker use of generic names will contribute to this impartiality. If trade names are used, those of several companies must be used rather than only that of a single manufacturer.
6. Unlabeled Uses of Products. When an unlabeled use of a commercial product, or an investigational use not yet approved for any purpose, is discussed during a presentation, the speaker is required to disclose that the product is not labeled for the use under discussion or that the product is still investigational.

When you submitted your abstract you agreed to abide by all these policies. Please be certain to comply with them during your presentation. The meeting Proceedings will be published on USB drive only, with the full text of all accepted abstracts available to advance registrants online on 25 April. Submission of your work constituted a commitment by the author(s) to present if invited. Unexcused failure to present will jeopardize participation in future ISMRM programs.
