### **POSTER SIZE**

The board will be used **VERTICALLY**. Dimensions of the poster board are 7 feet high x 3 feet wide. These are the maximum dimensions to follow when creating your poster but you should make your poster smaller.

Presenters should bring their own adhesive for their poster. IADR suggests reusable command strips. Take into consideration the poster material and size when planning the amount of adhesive to bring.

### **PRE-REGISTRATION REQUIREMENT**

All presenters must pre-register and pay the applicable fee by the **May 1, 2018** presenter pre-registration deadline. If you do not pre-register, you will NOT be allowed to present at the meeting and your abstract will be withdrawn from the final printed Program Book and will not be citable as appearing in the special edition of the *Journal for Dental Research*.

Approximately one week after the presenter registration deadline, a notification confirming your participation with your final presentation and sequence numbers will be sent. The notices will be sent to all presenters at once after the registration deadline. Notifications are not sent out after individual registration. If you need an invitation letter to get a visa to enter the United States, please check the applicable box when registering and a letter will be sent to you.
