- If you are a candidate for the Young Investigator Poster Award, you must also attend your poster during the Award Poster Session located near the Exhibit Hall on Tuesday, 4 April, 15:30 16:15 when reviewers will be judging the presentation of your poster. Please note the Judging Criteria posted in the "Abstracts" section of the AMP Global 2017 Congress website, http://gcmp.amp.org/awards/awards-information/amp-global-young-investigator-abstract-poster-award/. All Young Investigator Poster Award applicants have an even-numbered poster and must also present their poster on Wednesday, 5 April, 10:00 11:00.

Please note: All titles will be correctly formatted in "title case" in time for publication in the Program Book. Times indicated above are subject to change. You will be notified of any changes no later than March 1.

Poster Format: The poster size should be prepared in posters prepared in DIN A0 size (841 × 1189 mm), portrait format and must include the following elements:

- Introduction / Background: a brief discussion of the background or rationale of the study and/or the question addressed
- Materials and Methods: the experimental approach, materials, and methods used in the study
- Results: the data and results obtained in the study
- Conclusions: the conclusions and/or implications of the results References and Acknowledgements
- Including the Abstract is optional unless the scientific content has been altered since its submission. If substantive changes to the data and/or conclusions have been made since the abstract was submitted, the following must accompany the poster presentation: (1) a clear notice in the poster content stating that the abstract has been revised since submission, and (2) the revised abstract must either be printed on the poster itself or posted as a separate document on the poster board.

PRESENTING AUTHOR INFORMATION: As a reminder, the First Author is also considered the Presenting Author and undertakes responsibility for the following:

- The Presenting Author is expected to register for the AMP 2017 Global Congress and attend the poster at the assigned time period to discuss the study and answer questions. If the Presenting Author is unable to attend the Global Congress to present the poster, every effort should be made to arrange for one of the other authors to present the poster. Both AMP (ampeducation@amp.org) and the Global Congress Organizing Committee Chair, Dr. Margaret Gulley (margaret_gulley@med.unc.edu) must be notified. Failure to defend one's study by not attending the poster during the assigned time period is a violation of the AMP Scientific Integrity Policy and may result in forfeiture of future abstract submission privileges.
- The Presenting Author is expected to ensure that the abstract poster conforms to the Rules for Poster Display at the Global Congress (*i.e.*, poster display size, format, and schedule).

MEETING REGISTRATION: Presenting authors are required to register for the Global Congress. Register for the meeting at http://gcmp.amp.org/registration/. Early Bird Registration Deadline is January 24th.
