We would like to remind you that authors of all accepted papers for EMBC'18 must upload the final versions according to the instructions given on the conference website. Even if no changes are recommended a final version of the paper MUST BE UPLOADED. The final version should reflect the revisions in response to reviewers' comments, if available, and fix ALL format issues. Manuscripts not following the format requirement of EMBC'18 will be excluded from the conference proceedings, so please revise your paper carefully based on the reviewer's comments.

The final version of your manuscripts must be submitted by April 18, 2018.

and must comply with IEEE Xplore PDF standards, otherwise your paper may be removed from the final program. Please follow the instructions on the Papercept Submission site to properly convert your papers.

Please also make sure that your name and paper title are entered in 'Title Case' NOT in all 'UPPER CASE'. If you have entered your name in upper case when entering your PIN details, please correct this as well, by updating your Papercept account. Please also enter the names of all authors in correct order when uploading the final version of your manuscript. What you entered will be reflected in the program book and in Xplore and PubMed indexes.

As stated, all four-page contributions to EMBC are indexed in PubMed. Hence, we need to comply with the PubMed requirement that all EMBC papers contain a statement indicating that approval to carry out experimental procedures involving human subjects or animals was obtained from the appropriate committee. Please review your paper and make sure that a statement in this regard is included in the final version of your paper. We will have to reject all the papers that do not contain such statement when experimental procedures in human subjects or animals are presented in the paper. For those investigators whose Institutions do not have formal ethics review committees, the principles outlined in the Helsinki Declaration of 1975, as revised in 2000, should be followed. Examples of appropriate statements to fulfill the PubMed requirement are.

"The experimental procedures involving human subjects described in this paper were approved by the Institutional Review Board". "The Institution's Ethical Review Board approved all experimental procedures involving human subjects". "The experimental procedures involving animal models described in this paper were approved by the Institutional Animal Care and Ethics Committee".

It is the responsibility of the submitting Author to ensure that the document was viewable and without errors that would prevent the Conference from including the paper in the electronic proceedings.

In order to upload the paper, one of the authors must complete payment of the appropriate conference registration. In addition if your paper has more than 4 total pages, the author must also pay the extra page fee before they will be able to upload the final paper. If an author has more than 2 accepted papers they must also pay the extra paper fee for any additional final papers being submitted. Specific author registration instructions can be found on the conference website.

Only corresponding authors may upload the final paper.

The final version of papers (excluding any one page minisymposia/invited abstracts/special session/one page

research paper) will be indexed in IEEE Xplore and Medline/PubMed. There is no distinction made between conference poster and podium/oral presentations on IEEE Xplore.

By contributing a manuscript for consideration to EMBC'18, the Conference has the expectation that accepted papers will be presented either by the Corresponding author or a co-author. In order to maintain quality control of its Conference, EMBS has implemented a Policy for Authors regarding "No Show" Presentations. Authors who do not submit final papers by the deadline will be excluded from the Final Program. Submissions not following the IEEE format requirements may also be excluded from the program.
