## MEMORANDUM OF UNDERSTANDING

between

UNIVERSITY OF LJUBLJANA, Ljubljana, Slovenia

and

TEHRAN UNIVERSITY OF MEDICAL SCIENCES, Tehran, Iran

The University of Ljubljana and Tehran University of Medical Sciences wishing to promote co-operation between the two institutions in education and in academic research, agree to explore:

- a. co-operation on academic programmes;
- b. the development of joint research activities;
- c. the development of joint degree programs;
- d. and facilitate, university staff exchanges or mutual visits to both institutions;
- e. doctoral student training and development;
- f. student exchange and/or visiting programmes;
- g. the exchange of information, including the results of teaching and research collaboration;
- h. any other activities viewed to be mutually beneficial.

The terms of co-operation for each specific activity implemented under this Memorandum of Understanding (MoU) shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity and will be the subject of separate agreements.

This MoU is written in English in two copies and becomes effective from the day the representatives of both institutions affix their signatures below, and will continue for an initial period of five years, whereupon it shall be reviewed and may be extended by the mutual written agreement of both institutions. This MoU may be revised through the mutual agreement of both institutions and may be terminated by either party upon giving six months' written notice signed by the presiding officer of the notifying party.

Any use of the names 'University of Ljubljana' or 'Tehran University of Medical Sciences', including any of its constituent schools, departments, programmes or logos, relating in any way to the activities described in this MoU, shall be subject to prior written approval.

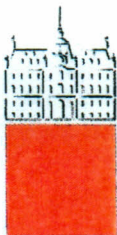
