**Purpose of the Memorandum of Understanding:**

**L' Université de Strasbourg and Tehran University of Medical Sciences**

In order to ensure the achievement of the above objectives, the partners will promote contact and cooperation between their departments, teachers, researchers and administrative staff, and will exchange all the information and have all the discussions they need in order to implement their cooperation.
