## 11. Main research themes

Prof. Dr. Krumeich has worked on a variety of topics including, mother- and child health care, reproductive health, culture, ethnicity and health, migration and health, higher education in health and infectious disease. Her research combines insights from (Critical) Medical Anthropology, Political Economy, and Science and technology Studies with Ethnographic and participatory research methodologies. Central to her research is the question how scientific knowledge and standards involving health, health education, and health related (technological) innovation can be translated to new and diverse contexts while maintaining effectivity and preserving sustainability. Trying to understand why the introduction of innovations into new settings is sometimes successful, sometimes has unforeseen results, but often results in failure, Dr Krumeich's research looks at how innovations evolve, how they adjust to new contexts and how they impact those contexts. Using ethnographic methods, it follows innovations on their travel from the place they were created to settings across the world, analyzing linkages between international trends, local culture, and scientific and technological development as well as the impact of these linkages on local health systems and other social institutions, and vice versa.

Starting point is that innovations are not static, but transform in interaction with the (cultural) context into which they are introduced. At the same time they change that context. End-users of the innovation (patients, health professionals, technicians, policy makers) play a crucial role in this type of research. Their experiences and practices shed light on this so called "co-production" or "co-evolution" of innovation and local and international context, and help to monitor its impact. Dr. Krumeich research therefor often involves stakeholder analysis and forms of participatory research.

#### Motivation

Selected publications illustrate both development and continuity in Dr. Krumeich's research into the relationship between human health, socio-economic and cultural environment and international trends.

In publication 10 Krumeich explores how illness perceptions and cultural notions on gender, shaped by historical trends, interlink with international economic relationships and impact child care and access to health care in local communities in Dominica. Publication 9 and 8 further elaborate this theme. Publication 9 is a review article and reflects on how precise and in depth ethnographic analysis is crucial for the understanding of local contexts and for the design and implementation of effective and sustainable health promotion interventions. Publication 8 shows Dr. Krumeich's increasing interest in the so called "Critical Medical Anthropology" and adds a more critical dimension to her ethnographic analysis. The article shows how current Dominican notions of anatomy and physiology are rooted in both West African and West European notions concerning the male and the female body and consequently how they justify gender inequalities. These notions came to Dominica during slavery, but are still underlying gender inequalities that are at the root of many of the problems women nowadays face in keeping their children healthy. Recent contacts with European trade companies further aggravated gender inequality and access to health (care). The article thus links local health culture to colonial history and international trade.

A similar ethnographic analysis also underlies the work by Quevedo and Maulana (publications 6 and 7), which, in line with more recent and critical approaches in Medical Anthropology, focuses on "local knowledge" as starting point for ethnographic analysis as well as for solutions. Starting from the idea that "western knowledge" is rooted in its own cultural traditions and that application of this knowledge may not always work in other contexts or can even have unintended, undesired side-effects. These two publications explore the benefits and challenges of participatory approaches, giving ample room to "local knowledge" systems.

Publication 5, 4, and 3 take Dr. Krumeich's critical approach yet a step further. The studies described in publication 5 and 4 explore how scientific knowledge (epidemiological studies carried out by the RIVM) as well as professional practices (occupational doctor) contribute to the actual creation of "ethnic" categories and result in social differentiation and inequality. Publication 3 shows how a too simplistic focus on "culture" and "cultural difference" often leads to misinterpretation of reality and contributes to the problematic position of ethnic minorities in the Netherlands.

Publication 2 explores how the design of innovations and their introduction into new contexts works out, trying to develop new theory on how to take divers contexts into consideration. As such it builds on Dr. Krumeich's previous work in Critical Medical Anthropology, on Ethnicity as well as on current and state of the art innovation theories in Global Health.

Starting from Dr. Krumeich earlier work, publication 1 provides a reflection on current "social determinants of health" models. The publication is a review article and integrates Dr. Krumeich previous work, and discusses current main stream models and proposes a different approach to the studies of the STDs.
